Terms and Conditions

Campaign Period

1st June 2018 to 30th November 2018

Eligibility

1. This campaign is open to all PFSB existing clients and new clients who open an account with PFSB (inclusive of customers who open an account during the campaign period) **except:**
 - i. L2 & L3 clients
 - ii. Local Participants
 - iii. Institutional and Corporate Accounts
2. No registration is required. Eligible clients are automatically registered for this Campaign.
3. Client who has pending request to close account and/or closes his/her account within the period of 1st June 2018 to 31st December 2018 will be automatically forfeited.
4. PFSB has the sole discretion to exclude any person from participating in this Campaign without any obligation to furnish any notice and/or reason.
5. PFSB reserves the right to disqualify entries that do not meet the terms and conditions of the campaign and/or any other reason deem fit.

Campaign Mechanism

1. Lucky draw entry can be earned by trading all futures products offered by PFSB.
2. Participants' entry tickets will be categorized into 5 tiers based on total gross commission accumulated during the Campaign period.
3. One client is only eligible to one lucky draw entry ticket.
4. Total gross commission accumulated will be calculated at the end of the Campaign period which is 30th November 2018.
5. The calculation of total gross commission includes all call-in trades and/or trades executed through our online trading platforms.
6. Clients' account numbers will be used for the lucky draw identification.
7. Prizes are subject to change without prior notice. PFSB reserves the right to change/modify the proposed prizes to something of equal or similar in value.
8. Prizes are strictly non-transferable to any third party and cannot be converted to cash.
9. There are five tiers of rewards for the campaign. The entry ticket is given and categorized based on the total gross commission accumulated during the campaign period as tabulated in Table 1 below:

Campaign Winners and Prizes
